This does not include smaller outgoings, I have only included the larger amounts.

Today we have **see in the account**.

We have to find a certain amount to cover everyday running, including green maintenance, insurance, utility costs, registrations etc but having worked out the costs of all these if we register 60 Full paying members then we can cover all the costs. The cost of full membership will however have to increase by £10 to £75 per year. That works out at £10.50 per month or just over £2.50 a week. This figure was agreed at the last AGM.

The greatest expense is still the green maintenance which at present is £4000 per year. This service is unavoidable as we have not the members to cut the green, treat it and look after it as Bothams (The present service providers) can do.

We also have £ in another account which is there for emergency expenses. Paul Lundy made the very valid point that we should, where possible, try to carry out any tasks around the green or pavilion ourselves rather than pay outsiders (need to recruit electrician and plumber members).

Several suggestions were made from the floor with ideas to raise money including more raffles, money raising competitions and sponsorship. One difficulty with sponsorship is that local planning rule prevent us having advertising boards around the green.

The treasurer's report was proposed by Richard Gagen, seconded by John Fisher and accepted without a vote.

6.0 Subscriptions for 2023

At the 2020 AGM it was agreed to increase subscriptions £65 for 2020, Increasing to £75 in 2021.

However COVID came along and in 2020 we charged £30 subscription and kept it at £65 in 2022.

Three years since the last AGM in 2020 can probably be best described as unprecedented in most of our lifetimes and interesting, but we managed to get by

Shortly after the 2020 AGM the first lockdown was enforced putting a complete stop to any sporting activities, including bowling. This first lockdown was ended in mid-May 2020. And we were allowed to open the green, but with very restrictions.

We were very much on our own, with little or no guidance from the British Crown Green Bowling Association, South Yorkshire or Sport England.

We had to make our own interpretation of the rules and hope that we did not infringe law. Most of the proposed actions. Were bounced off Paul Lundy at the time. And we came up with some guidelines for getting people playing again. Including, having to book the green, limiting the numbers on the green, Social distancing handling the equipment. In retrospect we may have been a little over zealous, but were concerned about both member safety and possible hefty fines.

I would like to thank everyone. For playing their part. Keeping to the rules. And booking the green.

In 2020, we did run some novel competitions, compliant with tight restrictions, which I think everyone enjoyed under the circumstances. We also ran the Seniors Shield, Ladies Singles and Hasnip Shield club competitions. We had intended to keep the green open throughout 2020. But another lockdown was imposed early in November.

In 2021 we were able to open the green at the end of March but started the season much as we had ended 2020. The same rules applied and the green having to be booked.

In mid May restrictions were relaxed somewhat, green booking stopped, the leagues started and we ran more club competitions.

In 2021 we ran the Seniors Shield, Ladies Singles, Hasnip Shield, Bryan Hall Trophy and Turkey Trot.

2022 was almost back to normal, with a full league programme. The total number clubs playing in the league fell, but we were able to put out extra teams in the Dinnington ladies and Friday Doubles.

We ran an almost complete internal competition programme; Pearce Trophy, Mulroy Trophy, Vets Singles, Bryan Hall Trophy, Hasnip Shield and Turkey Trot. For the first time since 2019 we held the presentation night.

2022 was a successful year for our teams.

The Saturday singles teams combined to win the Stones Cup.

Vets "A" team won Division 1 singles trophy and were runners up in Division 1 doubles. The Saturday Singles "B" team won Division 2 and have been promoted to Division 1.

On the downside the Maltby Tuesday men's team was deoted from division 1.

Our successful run in the Yorkshire Plate has come to an end. This competition is now an open, handicap competition.

Defibrillator

The defibrillator continues to be registered with the ambulance service and is regularly checked.

During strict lockdowns this gave the opportunity to also check all was OK with the green and pavilion.

However there is a cost. The pads need replacing if used or expired(cost £40) and a battery replacement is £135. The battery was replaced during shutdown. In 2022 the defibrillator was deployed, but did not function when returned. The battery was replaced under warranty.

These costs are not covered by the NHS. Ideas sought for fund raising in the immediate locality.

8.0 Social Secretary's Report – presented by Jenny Shaw

Last years presentation evening at the Sitwell Golf Club was very enjoyable, with excellent food and good entertainment from a lady vocalist.

Unfortunately, quite a few members were unable to attend due to holidays. This year, the presentation evening will be in November, so hopefully this will be more suitable than October.

So far this year there have been a couple of coffee mornings and a couple of social evenings. For anyone who hasn't been to any of these events, they are very enjoyable. Tea / coffee and cake for £1.50 per person. They also enable members to keep in touch. The next coffee mornings February 23rd and on March 9th a social evening.
